### SITE RULES AND CONDITIONS OF ENTRY

FAILURE TO COMPLY WITH THE FOLLOWING CLAUSES RESULT IN CANCELLATION OF SITE OR  
EVICTION FROM GROUNDS

1. OUTDOOR SITES ONLY
2. We are a Waste Wise event in the Alpine Shire – all single use plastics are BANNED. More info can be provided upon request.
3. **GATE ENTRY:** You must show the ticket provided (as supplied at time of application confirmation) at the gate or purchase a new one.
4. **CHECK IN and SITE LOCATION:** Upon arrival you must see or call the Chief Trade Steward Belinda Ramia 0411 329 690 or visit the Secretary's office. You will be allocated a site and directed accordingly. Do not park without following instructions from Chief Trade Steward.
5. **SETTING UP:** Stalls are to be set up **no later** than 9am on Show Day – gates open from 6am. Vehicle movement will not be permitted after that time. Please get in touch with the Chief Trade Steward or Secretary if you need to come earlier or the night before.
6. **PACKING UP:**
  - a. Option 1 Day program (9am to 4pm) – no vehicle movements before 4pm. At 4pm, contact the Chief Trade Steward or Secretary and you will be guided to the exit.
  - b. Option 2 Day and Night Program (9am to 9pm) – no vehicle movement before 9pm. At 9pm you can exit with caution or proceed to set up camp as directed by a Committee member.
7. **PUBLIC LIABILITY INSURANCE:** The Myrtleford Agricultural and Pastoral Society will not, under any circumstances be held responsible for any loss or damage to the stock in trade, etc., or any part thereof, of any space holder and/or exhibitor from any cause whatsoever. **INSURANCE IS THE STALLHOLDERS RESPONSIBILITY.** Your certificate of currency must be provided when lodging this application.
8. The running of raffles by stall holders is prohibited.
9. All electrical appliances, cables and gas bottles must be tagged, stamped and in date.
